Financial Assistance†

The AVEO ACE Program is committed to helping identify financial options to support access to FOTIVDA for your patients. Depending on your patient's insurance, there are programs and organizations that may help pay for FOTIVDA including:

- \$0 co-pay for commercially insured patients through the AVEO ACE Co-pay Assistance Program up to a \$40,000 annual limit
- Free drug for eligible patients who are uninsured or underinsured through the AVEO ACE Patient Assistance Program
- Patients with government insurance are excluded. Additional restrictions and eligibility rules apply
- Referral to independent third-party organizations for co-pay support
